NOTICE TO THE PROFESSION AND THE GENERAL PUBLIC ST. JOHN'S, GRAND FALLS-WINDSOR AND STEPHENVILLE PROVINCIAL COURTS ISSUED: NOVEMBER 28, 2025 COURT OPERATIONS

CIVIL HEARINGS, TRAFFIC HEARINGS AND CONTRAVENTIONS ACT CASES FOR ST. JOHN'S, GRAND FALLS-WINDSOR, AND STEPHENVILLE PROVINCIAL COURT

Civil hearings, traffic hearings, and *Contraventions Act* matters will be adjourned indefinitely, and the parties will be contacted by the Court regarding rescheduled dates.

CHANNEL-PORT AUX BASQUES CIRCUIT

Travel to the Channel-Port aux Basques circuit will be suspended following the December 3 to 5, 2025 circuit. All matters scheduled for future circuits will be scheduled in Stephenville Provincial Court and participants will be required to travel to Stephenville Provincial Court unless otherwise directed.

BAIE VERTE CIRCUIT

All cases currently scheduled for the Baie Verte circuit will be called in Grand Falls-Windsor Provincial Court and participants will be required to travel to Grand Falls-Windsor Provincial Court unless otherwise directed.
