President's Report

Welcome to the winter edition of *Benchers' Notes* – my first edition as President. The past number of months have been extremely busy and I am pleased to have this opportunity to highlight some of the events since my term began.

Firstly, I would like to thank my predecessor, Mr. Barry Fleming, QC, whose leadership and support was phenomenal. I am honored to have

had the opportunity to work alongside Mr. Fleming, QC and with my fellow Benchers in this capacity.

On June 9, 2017 it was a busy day here at the Law Society. Along with a Benchers' Convocation, Annual General Meeting, Benchers' election and Annual Dinner, Justice Sandra Chaytor was sworn in as a Justice of the Supreme Court, Trial Division. I gave remarks at the ceremony and attended the reception afterwards. Decisions, Decisions

Below is a brief summary of some of the decisions taken by Benchers during the period from April 2017 up to and including June 2017.

April 2017:

The April 10, 2017 meeting of Benchers was called to order by the President, Barry Fleming QC.

The Education Committee presented the first report and Benchers approved five transfers under the National Mobility Agreement, eleven Certificates of Fitness, five applications for Non-Practicing status and three applications to resign membership.

Next, a written report from the Library Committee, which proposed that Benchers repeal Part III of the Rules relating to the Library, was considered. The rationale was that the rule had been developed at a time when the library was separate from the Law Society and primarily funded by the Law Foundation with a Library Committee addressing budgeting and operational matters. As the Library was now almost fully funded by the Law Society with management of operations and budgeting being dealt with by the

Librarian under the oversight of the Executive Director, the old rules were outdated. The Chair confirmed that the Library would remain available to the public. Benchers approved the repeal of Rule 3 – The Library.

Law Society accountant, Richard Yabsley joined the meeting and highlighted some important aspects of the draft financial statements for 2016 which Benchers approved subject only to the inclusion of the actuaries figures re: CLIA, which had been communicated to Benchers by Mr. Yabsley, and any consequential amendments required to Notes 8 and 12.

Following the financial report, Barry Fleming, QC summarized his President's report which highlighted his activities from February 2017 – April 2017 and thanked the Executive Committee members and staff of the Law Society for their helpful assistance and advice.

Next on the agenda was the discipline report where memos recommending changes to Rule 9 were provided. Benchers approved that the Notices of the Motions be dispensed with and went on to approve amendments to Rule 9.07.1 - which would allow sharing of information with other law societies and, Rule 9.3 - relating to the requirement for lawyers to notify the Law Society of any charges (as opposed to findings or pleas of guilt) which could lead to a period of incarceration. After the report, Barry Fleming, QC took a moment to express gratitude to Phyllis Weir for her years of dedicated service to the Law Society and wished her well in her retirement.

Morgan Cooper, the Law Society's Federation Representative, reported that the Federation's priorities are as follows: the review of the National Committee on Accreditation; the Truth and Reconciliation Advisory Committee and the Anti-Money Laundering initiative which involved a review of our rules. He

went on to note that the next Council meeting would be in Iqaluit and that he had expressed the view that there should be an attempt to maximize the opportunity to engage with the community.

June 2017:

The 9 June 2017 meeting of Benchers was called to order by the President, Barry Fleming, QC.

The Education Committee provided the first report and Benchers approved six transfers under the National Mobility Agreement and eighteen Certificates of Fitness, eight applications for Non-Practicing status and five applications to resign membership.

Benchers went on to approve the appointment of Rebecca Redmond McLean, Kyle Rees and Peter Ralph, QC to the Library Committee and Donald MacBeath, QC to the SS Daisy Legal History Committee. Benchers also approved the appointments / reappointments of Law Society Committee Chairs and the reappointment of F. Geoffrey Aylward, QC and Sheri H. Wicks to the Law Foundation's Board of Governors.

Following the Insurance Report, Barry Fleming, QC summarized the President's Report and thanked Benchers for their patience and support over the past year.

The Discipline Report was then provided to Benchers, followed by the Federation Report whereby Morgan Cooper advised Benchers that the Litigation Committee had recommended the Federation intervene in the case of *Iggillis* v. *CRA* where the issue of common interest privilege versus solicitor-client privilege was being addressed.

Following the presentation of the Financial Report, Chris Curran, QC joined the meeting. Mr. Curran, QC thanked Benchers for their financial

support for the SS Daisy Legal History Committee and noted the recent publication of the "Discourse and Discovery: Sir Richard Whitbourne Quatercen-tennial Symposium." He also informed Benchers of the plan to reenact the Labrador Boundary case during the Bar Admission Course.

Mr. Fleming, QC went on to express his thanks to everyone: to the Chairs of the Committees for their great work; to Brenda Grimes, QC and the rest of the staff at the Law Society, pointing out that an incredible amount of work gets done that is never seen; and the Executive Committee for the exceptional efforts dealing with tough issues while always maintaining a collegial spirit.

Convocation then broke for the AGM and, upon resumption of the meeting, the Executive Committee was presented for approval, namely, Paul Burgess (President), Don Anthony (Vice-President), Barry Fleming, QC (Past President), Ian Patey (CAC Chair) and Ann Martin. Benchers approved the Executive Committee slate.

The Court of Appeal Legal Assistance Clinic

On 23 June 2016, the Supreme Court of Newfoundland and Labrador - Court of Appeal launched the Court of Appeal Legal Assistance Clinic, a pilot project intended to promote access to justice and legal education. The Clinic offers free legal assistance to people who do not have a lawyer and are seeking legal advice about their appeal. The Clinic is held one evening a month and volunteer lawyers meet with not more than four clients per Clinic for a period of 30 minutes each to provide summary legal advice and assistance. All clients are required to complete a waiver and intake form prior to their appointment. Volunteer lawyers are not expected to appear in court or complete any legal documents for clients. If a volunteer lawyer sees merit in the case, they may choose to provide further pro bono or low bono representation.

The Clinic is now in its second year of operation and recently began offering clients province- wide the ability to avail of services through telephone appointments. The Clinic has had a very successful first year and hopes that by improving the availability of services it will continue to build on this success and continue to improve access to justice for people throughout the province.

While the Clinic's success relies on the cooperative efforts of court staff, legal research officers, and the sheriff's office, the key has been the dedication of volunteer lawyers who generously offer their time and expertise. Those who have volunteered report a high level of satisfaction as their participation allows them to provide effective service, improve their knowledge of areas of law which may not be the focus of their current practice and acquire new contacts while also contributing to the community. It is something volunteers say they are passionate about and we would encourage others to participate in this exercise of community service.

Access to justice in Canada is in crisis. This Clinic is an opportunity for all who work in the legal system to make a difference for those who struggle to find justice. The Court welcomes any help in achieving this goal and appreciates the commitment of all those involved.

Law Society Library

For the 2017 year, the Law Library staff have been working on three very large inter-related projects. We started with the acquisition of a new library catalogue system with a new web-based interface or WebOPAC. For many years the Law Library was using the DBTextWorks system. However, for various reasons, that program became dated and was no longer able to meet the needs of the library. After careful analysis we selected the ResourceMate Integrated Library System (ILS) by Jaywil Software Development Inc. The old catalogue was migrated to the new database and the new catalogue came online in May. The open access catalogue is available for members and the public at < https://17941.rmwebopac.com/>.

In order to increase browsability and the range of cataloguing for new content, the decision was made to switch from the American cataloguing schedule to the Canadian schedule known as *KF Modified*. This second project is a very large

and extensive one as we are reassigning call numbers to our existing collection as well as to new items as they are added to the collection. This does mean that, for most of 2017, our collection has been in two parts – the newly reclassified items and the older content. Members have been very supportive and been able to work with both systems during our period of transition.

The third project is taking place at the same time as the call number classification and that is a collection review. We are reviewing our catalogue and our holdings to ensure that we have accurate inventory and records for the items in the collection. Each item record is being reviewed for accuracy and full subject headings. At the end of the project the Law Library will have a more thorough and accurate record of its holdings and items will be easier to locate and retrieve for patron searching and access.

The Law Society is committed to the movement to support Access to

Justice. As part of this movement, the Law Library has committed to hosting the Newfoundland and Labrador Access to Justice Steering Committee's Access Law Clinics. In 2017, there were two held - one on Family Law in the spring and one on Wills and Estates in the fall. Both were well received. As part of the Access to Justice Initiative, the Law Library resources are available to members of the public who are conducting legal research. Members of the public are welcome to use the resources on site, but they do not have borrowing privileges.

2017 has been a very full and busy year for the Law Library. We have been engaged in research and reference assistance for our members, detailed cataloguing projects, and supporting the provision of legal services for the people of Newfoundland and Labrador. We look forward to continuing this work in 2018.

Insurance and Risk Management

The Most Common Causes of Insurance Claims

No lawyer is immune from an insurance claim. But understanding the most common causes of insurance claims can help you build risk management skills as a line of defence.

The pie chart illustrates the relative proportion of most common causes of errors in the Lawyers` Insurance Programme claims portfolio.

The top four causes of loss illustrated in the pie chart, and which constitute 98% of our claim files, are discussed below:

1. Systems / Procedures / Administration

The most common errors (52%) deal with administration and time management issues such as failure

to follow-up, inadequate investigation, inadequate review or preparation or procrastination.

It seems to be human nature to put off tasks until the deadline is looming, which makes missed deadlines a major source of paid claims but time management claims are not always the result of simple procrastination. In some instances, the lawyer fails to ascertain the correct limitation period on a matter or, even if he or she does know the limitation date, fails to properly calendar or act upon the deadline as it approaches.

There are a number of steps you can take to avoid missing a crucial deadline. For example, use practice management software with tickler systems to alert you to approaching deadlines. Build in a timely cushion on deadlines and reminders that can help prevent this type of error when there are

unexpected problems that stop you from meeting a deadline for a filing (e.g. weather, sickness, a trial). We strongly encourage you to issue your Statement of Claim as early as possible.


Inadequate investigation is best described as failure by lawyers to take the extra time or thought to dig deeper and ask appropriate questions in order to uncover all the facts or develop sufficient understanding of a client's matter.

These claims can arise in any area of law. We see them most commonly in busy real estate practices, where rushed lawyers miss deficiencies in a condo status certificate, misread a survey, or don't find out the long-term plans a client may have for a property (so that they can ensure those plans are viable). In litigation, it could mean not making a reasonable effort to identify all the parties to an action within the limitation period. In wills and estates law it could mean not inquiring into the capacity of an elderly client or failing to ask about the existence of previous wills.

The best way to avoid these claims is to simply slow down. Take the time to read between the lines so you can identify all appropriate issues and concerns. Ask yourself: What does the client really want? Does everything add up? Are there any issues or concerns that should be highlighted for the client? If something doesn't add up, dig deeper.

2. Communication Related Errors

The second most common cause of claims are lawyer/client communication-related errors. Poor communication disputed instructions



or perceived limited retainers. These claims account for 32% of the errors we see.

Misunderstandings about what actions the client expected the lawyer to take, or the expected outcome/cost of a case, often result in claims. Limited scope retainers may increase these risks. Proper documentation of instructions, detailed notes of client conversations and reporting letters can help the Claims Review Committee defend these claims should they arise.

There is much that can be done at every stage of the matter to prevent these types of claims. Right from the outset, a well-drafted retainer letter can establish for a client reasonable expectations about how the matter will proceed and what the lawyer will (and won't) do for them.

As the matter progresses, it will be important to document conversations with the client, your advice, and the course of action the client wishes to pursue. This documentation can be a lifesaver in the event of an insurance claim. Clients may later say they asked the lawyer to do X and it wasn't done; or the lawyer may have done Y and the client claims he didn't authorize this course of action. If there is no documentation of lawver/client conversations, the claim then turns on credibility, and our experience has been that courts are more likely to believe the client's more specific recollections over the lawyer's typically vague or non-existent memory.

It is an unfortunate fact that while email and other electronic media provide more ways than ever for a lawyer to interact with clients, these lines of communication seem frequently to result in even more misunderstandings. Clients or lawyers read into, or infer from, email, advice or instructions that aren't there, or they miss the meaning of what was said, or read between the lines and make presumptions. Face-to-face communication is the best way to assure that miscommunications don't occur. If meeting in person isn't possible, at least telephone and talk to the client in an effort to avoid misunderstandings when important matters need to be discussed.

3. Failure to Know or Properly Apply the Law

Most lawyers are surprised to learn that a failure to know or apply substantive law is not the most common error that lawyers make. It is in fact the third most common type of error leading to insurance claims and accounts for eleven percent of the claims we receive. Some examples we have encountered deal specifically with failure to know about zoning requirements, and failing to address tax implications. Since each matter will differ in its complexity, lawyers who are not fully comfortable with a matter generally, or with some aspect of a matter in particular, should consider availing of our confidential Mentoring Program.

4. Clerical and Delegation Errors

Clerical and delegation-related errors are the fourth most common type of error. These errors include problems such as simple clerical errors, errors in mathematical calculations where work is delegated to an employee or to an outsider and is not then double-checked, and a failure to file documents where no deadline is involved. Delegation of tasks to knowledgeable support staff is an essential part of the operation of every practice because it makes lawyers more efficient and effective. Nevertheless, and ultimately, the lawyer is responsible for delegated work, and steps should be taken to review delegated work where appropriate. Extra care is especially warranted if there is something different or unusual on the matter.

Complaints Authorization Committee

The Complaints Authorization Committee, a statutory committee comprising two lawyers and a public representative all of whom are Benchers of the Law Society, reviews the allegation to determine whether there are reasonable grounds to believe that the lawyer has engaged in conduct deserving of sanction. If the answer is no, then the Complaints Authorization Committee will dismiss the allegation. The Act prescribes that a complainant whose allegation is dismissed by the Complaints Authorization Committee, may file a notice of appeal, within 30 days, with the Registrar of the Supreme Court.

When the Complaints Authorization Committee's opinion is that there are reasonable grounds to believe that the lawyer has engaged in *conduct deserving of sanction*, there are two results:

- (i) the *allegation* is considered as constituting a Complaint; and
- (ii) the Complaints Authorization Committee may issue a letter of counsel or a letter of caution to

the lawyer, or instruct the Vice-President to file the Complaint against the lawyer and refer it to the Disciplinary Panel.

Counsel is advice. Caution is a warning. Both are intended to assist the lawyer in his or her future conduct. A finding of guilt has not been made against the lawyer because a finding of guilt could only be made following a Hearing.

The following information is provided to inform members as required by Law Society Rule 9.06(5):

A Letter of Counsel was issued by the CAC with respect to the following Complaint.

Complaint that the member's conviction under sections 253(1)(b) and 255(1) of the *Criminal Code of Canada* does not comply with the standard of conduct contemplated by the *Code*. The Complaints Authorization Committee noted that this was the member's first offence and that the member cooperated fully with the Law Society. However, in the opinion of the Committee such conduct

does not meet the standard of conduct required by the *Code* and expected by the public. (*Code of Professional Conduct* (2013), chapter 2, rule 2.1-1 commentaries 1, 2, 3 and 4).

Complaint that the member's conviction under sections 253(1)(b) and 255(1) of the Criminal Code of Canada does not comply with the standard of conduct contemplated by the Code. The Complaints Authorization Committee noted that this was the member's first offence and that the member cooperated fully with the Law Society. However, in the opinion of the Committee, such conduct does not meet the standard of conduct required by the *Code* and expected by public. Furthermore, Committee reminded the member that Law Society members are obliged to have knowledge of the Law Society Act, 1999, the Law Society Rules and the Code of Professional Conduct, including but not limited to reporting requirements, and to practice within the scope of them. (Code of Professional Conduct (2013), chapter 2, rule 2.1-1 commentaries 1, 2, 3 and *4*). ■
