UNLESS CIRCUMSTANCES REASONABLY REQUIRE OTHERWISE, AND THE
PRIOR APPROVAL OF THE CHIEF JUSTICE IS OBTAINED:

- (a) all materials to be filed in an appeal must be filed at least two weeks prior to the date set for hearing the appeal;
- (b) appeals will not be set down for hearing outside designated hearing days;
- (c) appeals will not, except in the case of applications heard during late May and June, be set down for hearing on any date that is later than the hearing days scheduled for the second month following the month in which the application for a day is being heard, and
- (d) appeals will only be set down for hearing on a Tuesday that is also an applications day, when none of the other dates in that sitting period is available.
