Seminar Overview:

Three topics in one morning! Professor Thompson returns to the Law Society of Newfoundland and Labrador to discuss: (i) the changes coming to the practice of divorce law from the Bill C-78 amendments, (ii) Bill C-78 and its impact on parents trying to relocate with children, and (iii) the ten (or more) hardest types of spousal support cases, plus advanced SSAG issues.

Seminar Presenter:

Rollie Thompson, Q.C.

Rollie has been a Professor at Dalhousie Law School (now Schulich School of Law) since 1982. He served as Executive Director, Dalhousie Legal Aid Service, between 1982-85 and 1991-94. He has received numerous awards for teaching, including: the Dalhousie Law Alumni Association and Dalhousie Law Students' Society Award for Teaching Excellence in 2001-02; the Vincent J. Pottier Award for Exceptional and Outstanding Contribution to Dalhousie Legal Aid Service in 2005; and the Award for Teaching Excellence in the Osgoode Professional LLM in 2016. He was also a recipient (with Carol Rogerson) of one of the AFCC-Ontario's "10 in 10" 10th Anniversary Awards of Excellence in Family Justice, 2018.

Rollie has served as Editor of the *Canadian Family Law Quarterly* and Co-director (with Prof. Carol Rogerson) for the Spousal Support Advisory Guidelines Project, with the Department of Justice (Canada) between 2001-2008. He was appointed Queen's Counsel in 2011.
