Seminar Overview:

There were a number of noteworthy labour and employment law cases in 2019. This seminar, which is being presented in collaboration with the CBA-NL Labour and Employment Law Section and the Law Society of Newfoundland and Labrador, will highlight a number of significant labour, employment, and Labour Relations Board decisions from Newfoundland and Labrador and other jurisdictions within Canada. There will also be a presentation regarding the Supreme Court of Canada's recent administrative law "trilogy".

Seminar Presenters:

David Conway, NL Labour Relations Board

David has been the Chairperson of the NL Labour Relations Board since 2017. Prior to that, he worked exclusively in the fields of administrative law and labour law as in-house counsel. David obtained his B.A. from McGill University ('96) and his LL.B from the University of New Brunswick ('99) before being called to the Bar in Ontario and in Newfoundland and Labrador.

Kyle Rees, O'Dea, Earle
