SUSPENSION FOR FAILURE TO FILE

If a member fails to file a report in Form 5.06A or 5.06B within the time required under section 5.06, or fails to provide additional information in compliance with a request under subsection 5.06(5), the Executive Director shall send a notice in writing to the member and/or firm informing the member and/or firm that if Form 5.06A or 5.06B is not filed within fifteen (15) days from the date of delivery of the notice to the member and/or firm, the membership or enrollment in the society shall be suspended until such time as the member and/or firm is in compliance.
