 - (iv) <u>AND FURTHER AGREES</u> that all civil actions to be taken against the lawyer hereunder shall be under the absolute control of the Society and that the Society may prosecute, fail to prosecute, or abandon any such claim, demand, cause of

action, action or suit against the lawyer as the Society shall, in the exercise of its discretion and without the necessity of consent or approval of the claimant, deem appropriate.
