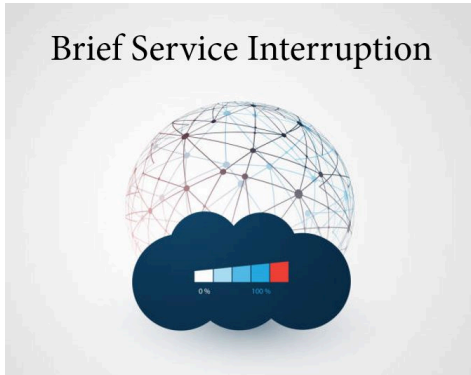

Unveiling the Omnibus Report on Mental Health in Canada's Legal Community

The Law Society of Newfoundland and Labrador is sharing the Omnibus Report for Phase II of the “National Study on the Psychological Health Determinants of Legal Professionals in Canada”, recently released by the [Federation of Law Societies of Canada](#) (FLSC). This groundbreaking study, conducted under the scientific direction of Dr. Nathalie Cadieux from the Université de Sherbrooke, provides vital insights into the mental health and well-being of legal professionals across the country, including those practicing in Newfoundland and Labrador.

The report highlights significant challenges faced by legal professionals, including high levels of stress, burnout, anxiety, and depression. The study revealed that 74% of participating legal professionals in Newfoundland and Labrador consider their work mentally taxing, underscoring the need for targeted interventions to support the mental health of our legal community.

The Law Society of Newfoundland and Labrador recognizes the critical importance of fostering a culture of wellness within the legal profession in Newfoundland and

Labrador. One of the key pillars of the Law Society’s strategic plan for 2021-2024 is to “Promote Health and Wellness” and, as the report notes, a number of steps have already been taken to promote health and wellness in the legal profession including efforts to destigmatize mental health issues, improved [CPD offerings](#), the introduction of the [Wellness Toolbox](#) and changes to the [bar admission and articling processes](#). The Law Society is committed to reviewing the recommendations carefully and continuing to explore ways to create a healthier work environment for everyone.
