Cases after 1971 were published by the Newfoundland and Prince Edward Island Reports. Further volumes covering 1950 to 1971 will be published when complete.

This 1949 volume represents a new standard in legal case reporting, featuring introductory essays, annotations, editors' notes, photographs, artwork, and other unique additions.

The Financial Transactions and Reports
Analysis Centre of Canada (FINTRAC)
has released a Special Bulletin detailing
the risks of money laundering and
sanctions evasion within the legal
profession. Under the *Proceeds of Crime*(Money Laundering) and Terrorist
Financing Act, this Bulletin outlines
typologies and potential indicators
related to the exploitation of legal
professionals in illicit financial activities.

Legal professionals are uniquely positioned to assist in financial transactions, including holding trust accounts and creating legal entities. This creates vulnerabilities that criminals may exploit.

The Bulletin may help members identify and assess money laundering, terrorist activity financing, and sanctions evasion risks, apply controls and measures to mitigate these risks, and effectively detect suspicious transactions.
