Loss Prevention Tip #64: Verify Pay Out Instructions Before Transferring Funds A BC law firm recently lost over \$4 million to fraudsters after wire instructions were manipulated via a compromised email account. The fraud could have been prevented with a simple verification call.

Before transferring funds, always verify payment instructions by phone or in person using trusted contact details from your file or a reliable source—not the email providing the instructions. This applies whether the instructions come from a client, another law firm, or a financial institution.

To help prevent wire fraud, ensure your firm:

- Has a verification protocol for all trust fund transfers.
- Uses multi-factor authentication and strong password practices.
- Trains all staff regularly on cybersecurity risks.
- Implements routine backups and robust email security.

If you suspect fraud, act immediately:

- Notify your bank and request a claw-back.
- Contact your IT support and cyber insurer.
- Report any potential loss of trust funds to the Law Society/Lawyers' Insurance Program.
