## Excess Program Renewal Now Open

The Law Society of Newfoundland and Labrador is a subscribing member of the Canadian Lawyers Insurance Association (CLIA), a reciprocal insurance exchange established in 1988. As a practising insured member, you have:

- Mandatory Errors and Omissions (E & O) insurance with a limit of \$1M per claim and a \$2M annual aggregate limit; and
- Mandatory Cyber insurance ranging from \$100K to \$250K for various common cyber claims. See the Cyber Insurance Overview information to better understand your mandatory coverage.

Additional or excess insurance is also available through CLIA's Voluntary Excess Program (VEP). Excess insurance is optional coverage that law firms can purchase as additional protection beyond the mandatory coverage required by the Law Society. Coverage options under the VEP include limits of \$1M, \$2M, \$3M, \$4M, \$6.5M, \$9M, \$14M, \$19M, \$24M, \$29M, and \$34M. In addition, CLIA also provides additional cyber

coverage limits above the mandatory insurance. For more information, please click here.

New Release: Technical Compliance Publication Now Available





# PREVENTIVE JUSTICE: THE QUEST FOR CERTAINTY IN PREDICTING FUTURE HARM



The term "preventive justice" was first used in the 18th century and linked to laws aimed at preventing future crime. In many jurisdictions based on the common law, the past few decades have seen preventive justice schemes reinvigorated in association with a focus on risk assessment tools aimed at predicting the risk of future harmful behaviour. Recently, predictive machine learning algorithms have been used to inform judicial decision-making, including sentencing. Using case studies, this lecture will explore some of the legal and ethical issues raised by preventive justice schemes and will consider whether the quest for certainty in predicting future harm is any closer to being fulfilled.
