Cash Transactions and Recordkeeping Requirements and Client Identification and Verification Rules Amendments - Administrative Penalties

This is a reminder of amendments to Rules 15 and 16 to provide for administrative monetary penalties to address breaches of Anti-Money Laundering and Terrorist Financing (AMLTF) Rules, which came into effect on 30 June 2024. The revisions are designed to emphasize lawyers' obligations with regard to AMLTF and provide appropriate and proportionate sanctions for violations. Administrative penalties of up to \$2,500 in the first instance of non-compliance and up to \$5,000 for subsequent instances may be assessed. These Rules underpin our efforts to combat money laundering and terrorist financing activities in the legal profession, as lawyers' trust accounts may be targeted and utilized as a vehicle to commit criminal activities.

The Federation of Law Societies of Canada has also developed a five-module program, Anti-Money Laundering and Terrorist Financing in the Canadian Legal Profession, which can be found here. It is a complimentary course and is eligible for CPD credits once completed.
