Deadline for PLC Licence Applications, Amendments, and Cancellations

Please be advised that all initial applications for, amendments to, or cancellations of Professional Law Corporation (PLC) licences <u>must be submitted by 5 December 2025</u> to ensure sufficient time for review and processing before the Christmas break.

Applications received after this date may not be processed until the New Year.

The necessary forms are available as follows:

- Form 11.03A: Submit this form along with the required documentation to apply for a Professional Law Corporation Licence. <u>Please carefully review the 'Instructions for Completion' found at the beginning of Form 11.03A</u>.
- Form 11.03B: Submit this form, along with the applicable fee and any required supporting documentation, to the Law Society for amendments to your PLC.
- Form 11.07: If you wish to cancel your PLC licence, please submit this completed form and the required documentation as outlined in section 2.

Enhanced Access to DivorceMate for Members

Members of the Law Society of Newfoundland and Labrador can now access DivorceMate in a new cloudbased format at our Law Library.

The update means that the software now runs online through DivorceMate's secure servers instead of being installed directly on the device. The interface and features will feel familiar, while performance and Microsoft Word integration have been improved. Please note that, although DivorceMate operates in the cloud, access is limited to the library, and remote use is not permitted.

Law Library staff cannot perform DivorceMate searches on behalf of users due to the confidential nature of the material.

Members can access this resource 24/7 using their access card.
