

Fraud Prevention Advisory: Phishing Attack Targeting Law Firm Trust Accounts

A recent case of fraud, which led to significant unauthorized wire transfer withdrawals from a member's trust account as a result of a suspected email-phishing attempt, has underscored the need for ongoing vigilance and regular, up-to-date training for all legal professionals. Even the most risk-aware individuals can inadvertently engage with malicious communications, highlighting the importance of continued education and awareness.

Many risk-averse legal professionals avoid electronic banking; however, not having access to real-time banking can increase the risk of fraudulent transactions going undetected. For firms without full online banking access, it is possible to limit access to *inquiry only*. This allows you to monitor transactions in real time and identify any suspicious activity as it occurs, increasing the likelihood that the bank can intervene to reverse or stop unauthorized transactions.

Please see some quick tips below, specifically aimed at alleviating phishing risks.

How to avoid email hacks:

- Use strong, unique passwords for every account.
- Enable multi-factor authentication wherever possible.
- Be cautious of phishing emails. Avoid clicking on links or downloading attachments from unknown sources, and always verify the communication by following up with the sender by phone.
- Avoid public Wi-Fi for sensitive tasks unless using a VPN.
- Regularly review security settings on your email account.

Immediate steps to take if you click on a malicious link:

- Disconnect from the internet to reduce the risk of additional data being transmitted in case malware is downloading.
- Report the incident to your IT team or email provider.
- Do not enter any information.
- If the link led to a fake login page, close it immediately.
- Change the passwords on your email and any potentially compromised accounts, ensuring they are strong, unique, and protected with multi-factor authentication wherever possible.

- Clear browser cache and cookies to help remove any malicious scripts or tracking.
- Report cyber-related attacks as quickly as possible to your cyber insurer at [Cyber Claim Reporting](#).
