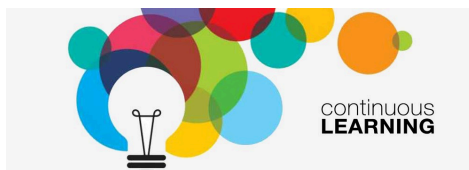

Intensive Trial Advocacy Program (ITAP) - 2026/2027

The [University of New Brunswick Faculty of Law](#) and the [Faculté de droit of the Université de Moncton](#) will again provide the [Intensive Trial Advocacy Program](#)

(ITAP), a week-long academic program designed exclusively for practicing lawyers. The 2026 English-language program will run from 20 to 26 June 2026, at the University of New Brunswick Faculty of Law. The French-language program will be offered at the Université de Moncton in 2027.

ITAP provides hands-on training in fundamental trial techniques applicable to civil, criminal, and administrative law hearings and trials. Enrollment is limited to 32 participants.
